INTENDED USE

The Alkaline Drain Cleaner is indicated for freeing pipes blocked by organic and inert deposits (grease residues, soap) and by limescale encrustations, hair, paper, sanitary towels, rags, cigarettes, etc.

METHOD FOR USE

One bottle of DISGORGANTE contains 6 doses. In the case of partially blocked drains, pour one or two doses of product into the drain, even in the presence of stagnant water, and wait about 2 hours before running the water, preferably hot, but not boiling. For completely blocked drains, pour about half the contents of the bottle and wait 3-4 hours before running the water. In more difficult cases, repeat the operation by adding one or two doses. Wait at least 30 minutes between one treatment and the next, taking care to run the water after each operation. Do not stand near the drain while waiting: the reaction may develop heat. Close the bottle carefully after use.

Avoid contact with acids and metals such as aluminum, tin, lead and gold surfaces. In the case of enameled surfaces, hot tubs, colored surfaces, make sure the color and enamel are resistant by testing in a hidden area. In the case of blockages in small drains, halve the dose of use. **Do not use Drain Cleaner with acids, bleach or other household cleaners. Do not use with suction cup.**
